

Regulations of the District Competition "The International Spelling Bee Contest"



Due to the current epidemic situation, class eliminations will take place online and finals in stationary mode.

Update: 02.01.2021

1. General provisions

The district contest "The International Speaking Contest" is organized by The International School based in Warsaw at Jagielska St. 2, hereinafter referred to as the Organizer.

The Organizer is an administrator of personal data processed in the contest. Personal data processed during the contest may be made available in paper and electronic form.

2. Objectives of the contest

The primary objective of the contest is to develop motivation of participants to learn English and to familiarize themselves with the formula of the contest known all over the world.

Specific objectives include:

- 1) identification and improvement of linguistic competences and vocabulary of primary school students,
- 2) practice and improvement of spelling skills;
- 3) work on public speeches,
- 4) promotion of students' talents,
- 5) learning motivation through competition,
- 6) integration of children from different schools and educational institutions.

3. Rules for participation in the contest

- 1) The Contest is for the students of grades IV-VIII of primary schools which implement English language program as an integral part of the curriculum where the number of English classes exceeds the number of hours specified in the core curriculum
- 2) In the finales the school shall be represented by:
One representative of each grade IV-VIII.
- 3) Representatives of schools shall be under the supervision of their teachers.
- 4) A completed registration process determines participation in the Contest.

During the Class Preliminary, 80% of words will be from the "word bank", 20% will be new words. During the finals, 60% of the words will be from the "word bank", 40% will be new words.

4. Registration

In order to register school for the contest, complete the School Registration Form and send it to email address: wioleta.poreda@internationalschool.pl by **March 6, 2021**. Registration requirements apply to students who have been chosen by English language teachers during internal preliminaries. If a Student Registration Card is not submitted by the deadline, it is tantamount to the school's resignation from participation in the Contest.

After completion of the registration process, the schools receive a detailed schedule of the contest which is sent to email addresses indicated in the forms.

5. Age categories:

There are 5 grade categories:

- gr.4
- gr.5
- gr.6
- gr.7
- gr.8

An entire class takes part in the contest. The students who take the first 5 places in class preliminaries will participate in the finals.

The finals of the Contest is scheduled for **March 12, 2021**, at The International School in Warsaw, Jagielska Street 2.

This stage is for the representatives of schools registered for the contest. Participants are assessed by the Jury appointed by the Organizer.

During the finals, Jury chooses the winners of each age category. The participants who take the 1st, 2nd, and 3rd place are awarded certificates and prizes.

The order of presentations is determined by the organizer.
